You are purchasing a Rhodesian Ridgeback puppy with limited AKC registration. This puppy is strictly for placement as a "family companion". This means that this puppy does not represent a standard that we consider desirable for breeding purposes.

By accepting this puppy, you are agreeing to spay/neuter your puppy, and upon so doing, shall provide the Breeder with written verification from a licensed veterinarian to the address shown above.

Where the safety of the animal is reasonable as determined by any licensed veterinarian, Breeder reserves the right to Spay/Neuter the puppy, where cost is not to exceed 125.00, payable by the buyer prior to the seller releasing the puppy to the buyers care.

This puppy has a detailed health record that will be sent via United States

Postal Service, certified mail within one week of delivery of the puppy. This record details the completed vaccination and worming schedule as well as the date of dewclaw removal. Your puppy has no known health issues.

We strongly recommend a good qualified veterinarian in your area that is familiar with the Rhodesian Ridgeback breed.

We warrant this puppy to be in good health and free from defects. "Free from defects" means free from any health problem that would normally be discovered by a licensed veterinarian performing a standard travel health checkup. Sufficient evidence of this checkup shall be any standard health certificate such as is normally required by any domestic airline.

From the date of whelping, you will have a 2 year puppy replacement warranty against specific defects. (These defects are limited to hip dysplasia, and dermoid sinus) This warranty is strictly contingent upon your purchase of a pet medical insurance adequate to treat such problems as are known to be inherent in the Rhodesian Ridgeback breed.

Your puppy has received up to date shots and worming. You are required to maintain your puppy's shots and worming on a regular basis. Failure to maintain your puppy's shots and or worming on a regular basis will void this warranty, as will failure to maintain pet insurance.

By accepting this puppy, Buyer agrees to complete a formal obedience training course with an AKC accredited organization, or with an organization approved by the breeder before the puppy is 6 months of age.

Buyer agrees to send e-mail of side view, and front view photos via digital means at 3 months, 6 months, 12 months, and 18 months of age.

If for some reason you should decide you do not want your puppy, you are not, under any circumstances, to deliver the puppy/dog to a "dog pound", "rescue organization", or any other facility that receives animals "off the street". You agree to deliver the puppy/dog back to the Seller, without any expectations of remuneration. Seller will take the animal back, but there are no refunds whatsoever. ***All deposits are Non-Refundable***.

If for any reason, the Buyers choice of a puppy cannot be delivered to Buyers care, Buyer agrees to accept a replacement pup either from the same litter, or from a subsequent litter available from our Kennel -
